CVRF generates the money to fund its programs by harvesting fish in the Bering Sea with its own fleet of vessels.

It is governed by a Board of Directors consisting of one member democratically elected from each community. CVRF is the largest Alaskan-owned seafood company in history and the first CDQ group to own and control the vessels that harvest the vast majority of its CDQ allocations.
